The _____, a company incorporated under the provisions of the Companies Act, 1956 having its registered office at _____ (hereinafter referred to as "Applicant", which expression shall, unless repugnant to the context or meaning thereof, include its successors and assigns), do hereby swear and declare as under:

THAT the Applicant is an occupant of the premises at _____ in support of which the Applicant has enclosed copy of _____ as proof of occupancy.

THAT the Applicant has requested the Tata Steel Utilities and Infrastructure Services Limited (Tata Steel UISL) as Distribution Licensee to provide an Electrical connection at the above-mentioned premises in the Applicants name for the purpose mentioned in the application form.

THAT Applicant undertakes that mere supply of electricity shall not be the ground of any claim of right, title or interest of land or building or premises against any person including but not limited to family member(s) and applicant should not raise any dispute in this regard. The electricity connection shall have no bearing on the right, title or interest of the Applicant corresponding to the land or building or premises and the Applicant shall only be considered as a consumer of electricity.

THAT the electricity connection which will be installed in the name of the Applicant shall be subject to the final outcome of any case or title suit or litigation pending before any court or forum involving the Applicant and any document received from Tata Steel UISL by the Applicant in respect of new electricity connection shall not be used by the Applicant as an evidence to prove his / her title to the premises.

THAT in furnishing the Declaration, the Applicant has clearly understood that should the above statements prove to be false or incorrect at any later stage, Tata Steel UISL shall have every right to disconnect supply of electricity of the Applicant without any notice and adjust dues against Consumer Security Deposit, if any.

THAT the Applicant hereby agrees and undertakes:

1. To indemnify Tata Steel UISL against all proceedings, claims, demands, costs, damages, expenses that the licensee may incur by reason of a fresh service connection given to the Applicant.
2. That all Electrical Works done within the premises are as per Central Electricity Authority (Measures relating to Safety and Electricity Supply) Regulations, 2010 and have been carried out by a licensed electrical contractor (in case the Applicant is an owner and wiring in the premises is new)

Or

That all Electrical Work done within the premises are as per Central Electricity Authority (Measures relating to Safety and Electricity Supply) Regulations, 2010 to the best of our knowledge (where application is for reconnection or Applicant is occupier of the premises)

3. Tata Steel UISL is indemnified against any loss accrued to the applicant on this account. Further, Applicant agrees that if there is any harm/loss to the property of the Tata Steel UISL as Distribution Licensee due to the fault in Electrical work within the premises of Applicant, all the liabilities shall be borne by the Applicant.
4. To pay the electricity consumption bills and all other charges at the rates set out in Tata Steel UISL as Distribution Licensee's Tariff Schedule and miscellaneous charges for supply as may be in force from time to time, regularly as and when the same becomes due for payment.
5. To deposit the additional consumption deposit as revised by Tata Steel UISL from time to time based on the consumption of the Applicant in preceding year.
6. To abide by the provisions of the Electricity Act, 2003 and its amendment up to date, JSERC's latest Electricity Supply Code Regulation, Tariff Orders and any other rules or regulations notified by the Commission, as applicable from time to time.
7. Tata Steel UISL shall be at liberty to adjust the electricity consumption charges along with any other charges against the Consumer Security Deposit paid by the Applicant, in the event of termination of the agreement prior to expiry of the contracted period or in case of nay contractual default.
8. To be responsible for safe custody of Meters, CTs, Cables etc. provided by Tata Steel UISL as Distribution Licensee and in case, there is any damage to equipment due to the reasons attributable to Applicant the same shall be chargeable to the Applicant. Further, all repercussions on account of breakage of seals of meters etc. or Direct/Dishonest Abstraction of energy shall be to the account of Applicant, as per the existing laws.
9. To allow clear and un-encumbered access to the meters for the purpose of meter reading and its checking etc.
10. That the Applicant would let Tata Steel UISL disconnect the Service connection under reference, in the event of any default, non-compliance of statutory provisions and in the event of a legally binding directive by Statutory Authority(ies) to affect such an order. This shall be without prejudice to any other rights of Tata Steel UISL including that of getting its payment as on the date of disconnection.
11. That Tata Steel UISL shall not be held responsible for any interruption or diminution of supply of Electricity.
12. All the above declaration given by the Applicant shall be construed to an Agreement between the Applicant and Tata Steel UISL.
