Implementation of Fuel and Power Purchase Price Adjustment (FPPPA) Charges for the period of Q3 FY 2022-23 of Licensee Tata Steel Utilities and Infrastructure Services limited

Fuel and Power Purchase Price Adjustment Charges are being levied to the consumers of Licensee Tata Steel Utilities and Infrastructure Services Limited on quarterly basis, based on difference of actual and approved power purchase cost, as per Jharkhand State Electricity Regulatory commission (JSERC) Distribution Tariff Regulations 2020. Fuel and Power Purchase Price Adjustment Charges for Licensee Tata Steel UISL

Fuel and Power Purchase Price Adjustment (FPPPA) Charges are being levied to the consumers of Licensee Tata Steel UISL on quarterly basis, based on difference of actual and approved power purchase cost.

FPPPA charges relating to **Q3 of FY 2022-23** have been calculated by us and are being charged to the consumers in the electricity consumption bills for the period **Jan'2023 to Mar'2023**.

Adjustment on account of increase in variable cost of power purchased during the period = Rs. 1212.93 lakhs (Rs. 8652.45 lakhs - Rs. 7439.52 lakhs).
