Tata Steel UISL invites applications for Officer Trainee from wards of employees.

Position	Officer Trainee
Eligibility	1. Employees Wards: Son / Daughter / Son - in-law (in case the employee has no son/Daughter-in-law)
Minimum Educational Qualification	(i) Employee Wards who have completed full time BE / B Tech / B Sc. (Engg.) in Civil / Water Engg. & Management/Electrical /Electrical & Electronics/ Electrical Instrumentation & Control Systems /Mechanical/ Mechatronics Streams from AICTE recognized institutes are eligible to apply. (ii) Those who are appearing in final semester examination in the above-mentioned branches of engineering are also eligible to apply. Their qualification for selection will be subject to producing the result having at least 55% marks in aggregate. (iii) The candidate must have secured at least 55% marks in aggregate in engineering. Only full (day) time courses will be considered. Candidates with Part Time / Correspondence / Distance Learning will not be eligible.
Age	The candidate should have been born on or after 1st June 1986. 1 year relaxation for SC/ST candidates
Other Guidelines	1. Those wards who are currently employed in Tata Steel UISL (OPR/ Non OPR) will not be considered. 2. Eligible employee wards, who are currently employed with Tata Group Company / Subsidiaries/ Associate Company will need to furnish an NOC from the present employer before being considered for employment. The NOC will have to be produced before the candidate is called for the interview. 3. All selected candidates will have to be declared medically fit as per Company's medical fitness standards before their appointment. 4. The placement of those selected could be at any location where the Company has its operations. 5. No reimbursement related to the travel will be made to candidates in this process. 6. Candidate who are found ineligible as per the laid down criteria at any stage of selection process will be immediately disqualified from further selection process
Selection Method	Eligible candidates will have to appear for Written Test. It will consist of Aptitude test (Multiple Choice Questions) and Domain Test (Multiple Choice Questions). Candidates qualifying in the Written Test will undergo a Panel Interview process. Selected candidates will be appointed as Officer Trainee and will undergo training for a period of one year during which they will be paid stipend. Their performance will be evaluated during training and on successful completion of training they will be appointed as Asst. Manager Level JM 13.
